## CONDITIONS OF HIRE

Reservations of Hunter's Rest are accepted by the owners on the following conditions:

CONTRACT  
OF HIRE

The hiring contract shall be between the Hirer and the owners of the property and shall be deemed to be made subject to these Conditions of Hire. The Contract of Hire is not effective until the owners dispatch to the Hirer written confirmation of a booking.

INITIAL PAYMENT

Bookings will be confirmed upon receipt by the owners of the required deposit payment. If the booking is made within 56 days of the holiday start date, the full rental will be required.

BALANCE  
PAYMENT

The Balance of Hire will be due for payment 56 days before the holiday start date. The owners reserve the right to cancel a holiday where full payment has not been received less than 28 days before the holiday start date.

CONFIRMATION  
OF BOOKING

Once Confirmation of Booking has been issued, the Hirer is responsible for the total price as shown on the Confirmation.

BOOKING  
CANCELLATION

In the event of cancellation, the deposit will be forfeit. If cancellation of booking is received by the owners in writing not less than 10 weeks before the holiday start date, the Hirer will not be held liable to pay the full Balance of Hire. If cancellation is notified within 10 weeks of the holiday start date, the Hirer will be liable to pay the full Balance of Hire. Should the owners manage to re-let the accommodation, any moneys paid (including the deposit) will be refunded.

MOTOR CAR AND  
PERSONAL  
BELONGINGS

Baggage and personal belongings are at the Hirer's risk at all times, and no responsibility can be accepted for loss or damage to any vehicle or its contents.

PARTY SIZE

Under no circumstances may more than the number of persons stated in the Confirmation of Booking occupy the property except by prior written agreement. In addition, the owners reserve the right to refuse or revoke (before or during the holiday) any bookings from parties which may in their opinion (and at their sole discretion) be unsuitable for the property.

HIRER'S  
RESPONSIBILITY

The Hirer is responsible for the property and is expected to take all reasonable care of it. The property and all equipment, utensils etc must be left clean and tidy.

DAMAGE

All damages and breakages are the legal responsibility of the Hirer and their cost shall be refundable on demand.

AVAILABILITY

The Hiring Contract is made on the understanding that the property will be available for the dates stated, In the unlikely event that the property is not available through events arising out of the owners control, the owners may be forced to cancel the booking. The hirer will be notified of any such circumstance as early as possible and all monies paid refunded in full.
